Every member will do their best to ensure that they do not give anyone cause to make a complaint about their actions, and will try to help others avoid such situations as well, because they understand that behaviour deemed unacceptable under the Membership Policies can lead to the cancellation of membership.

Each member will make good any financial commitments that they may make to the Club and they will help support Club activities through volunteering to assist with Club events or administration as appropriate.

Each member understands that personal information included in their application to the Club will be kept in confidence by the Club and not released to other members without their express consent.

Each member will realize that information given to them by other members such as telephone numbers and street addresses is often intended for them alone, and they will not give that information to others without the consent of the member in question.

Each member will not forget that the goal of the Club is to sponsor events that will be fun for all concerned, and will do their best to ensure that they contribute in a positive way to the realization of that goal.

IN CONSIDERATION of my being permitted to participate in the activities arranged by the Greater Vancouver Recreation Unlimited Club (the "Club"), I, for myself, my heirs, executors, and anyone else who may claim on my behalf **HEREBY WAIVE ANY AND ALL CLAIMS, LIABILITY AND DAMAGES** I may now or in the future have against the Club, its members, event organizers, and all persons acting under its authority, collectively described here as the Club, arising from any and all personal injury, death, property damages or loss sustained by me arising from or in connection with my participation in the activities of the Club however caused. **I FURTHER HEREBY RELEASE AND FOREVER DISCHARGE** the Club from and against all demands, claims, actions, damages, costs, and expenses arising from or with respect to death, injury, damages or loss to my person or property and any kind whatsoever, no matter how caused, arising from or in connection with my participation in Club activities including, but not limited to, if the same may have contributed to or been caused by the **NEGLIGENCE OR GROSS NEGLIGENCE** of the Club. **I FURTHER AGREE** to hold harmless and indemnify the Club from any and all liability for any damage or injury to the property or persons of any third party resulting from my involvement in or presence during any of the activities of the Club.

I ACKNOWLEDGE that the Club, in obtaining this waiver from me is doing so for the Club, including its members, trip organizers, and all persons acting under the authority of the Club. I also understand that I may be asked to sign another waiver for a specific event that I am participating in.

In the event that I act in any capacity for the Club, I appoint the Club as my agent for the purpose of obtaining an indemnity and release of liability from other members of the Club or persons participating in its activities.
